**THE COLORADO GUN COLLECTORS ASSOCIATION
POLICY FOR CONDUCTING ASSOCIATION MEETINGS**

Effective: August 1, 2024

1. Introduction.

The Board of Directors (the “Board”) of Colorado Gun Collectors Association (the “Association”), has enacted the following Policy effective as of the date set forth above.

2. Member Meetings.

2.1 Definition. Member meetings refer to those meetings described in Article X of the Bylaws and include the annual meeting of the Association and any regular meetings of the members that shall be called by the President or the Board of Directors or by a majority of the Board.

2.2 Parliamentary Procedure. Unless otherwise provided in the Association Documents, and except as set forth in the code of conduct below, meetings of the Members shall be conducted in accordance with (a) *Robert’s Rules of Order Newly Revised*, or (b) such other generally recognized rules of parliamentary procedure as may be adopted by resolution of the Board.

2.3 Code of Conduct. The following code of conduct shall apply to meetings of the Members:

2.3.1 Anyone wishing to speak must first be recognized by the meeting chair.

2.3.2 Members shall not interrupt anyone who validly has the floor.

2.3.3 When speaking, Members shall abide by any time limits, if any, set by the meeting chair for comment.

2.3.4 Members shall at all times speak and otherwise behave with common courtesy and civility. In particular, Members shall refrain from personal attacks, and from using profane, rude or threatening language.

2.3.5 Any comments should be relevant to the agenda item, or portion of the meeting at hand, being discussed.

2.3.6 No Member may speak for a second time on an issue unless invited to by the Chairman.

2.3.7 Members may not speak more than once on any one issue, subject to the discretion of the meeting chair.

2.3.8 Members shall obey all orders made by the meeting chair, including an order to step down (i.e., an order to stop speaking and yield the floor).
