# My Favorite Weapons

## Summarized by Rick Wilson

Bob, one of our long-time members, and an expert on the Civil War, gave our Lecture at the October meeting. As usual, it was a most interesting talk so I wanted to share it with those that could not be present.

He started out by saying he isn't a gun, a sword, or a uniform collector, but rather a collector of history.

The first item he talked about was a standard model 1861 rifled musket. The first ones were made at Springfield but later they were made by various contractors. This was made in 1863 by one of those contractors. The interesting thing is that it was most likely at the battle of Gettysburg because carved in the stock is 121 NYV with a red cross. This probably stands for 121st New York Volunteers. The red cross in this instance, is the Insignia of the first division of the 6th army corp. When he bought this rifle, he was hoping there would be a name somewhere, and indeed when he took the barrel off, inscribed in the barrel Chanel was the name "George Wallace" who was in the 121st, and most likely had this gun at Gettysburg.

Next, he talked about his Indian gun, a sharps carbine. He knows where it has been for the last 90 years. He offered up his reasons for why he thought it was a legitimate Indian used carbine. First the butt plate is missing and commonly they would be removed by the Indians to be used as hide scrapers. It has a number of tacks in the butt stock that have a lot of patina, and also a hide repair to the fore stock. When he got it, he could tell it had been of military issue because the stock had a scar on it that had been made by the sling swivel that was used by the calvary. He checked on the serial number, which was 96,448. Serial number 96,447 was issued to a trooper in Company B of the 1st California calvary. They only have the serial numbers for one of the eleven company's, so the odds are very good that this ended up with the 1st California calvary. They operated in the Southwest in NM, AZ, and Northern Texas and were mustered out in 1866 at a place called Baird's ranch in New Mexico.

Next, he talked about a pistol that was owned by Spruce McCoy Baird whose Baird's ranch is named after him. He fought for Texas as an officer in the war with Mexico. Later he was made Attorney General of New Mexico in 1860. When the Confederates came through in 1862, one column actually stayed at Bairds ranch. Bob has a picture drawn of the ranch by a soldier of the fourth Texas. After the Confederates retreated from New Mexico, he figured that he was probably no longer welcomed in New Mexico. He and his family retreated down the Rio Grande River to El Paso. There, he was made Colonel of the Fourth Arizona Calvary. The Union Army, thinking he was a Confederate sympathizer, and rightly so, confiscated his ranch. They then proceeded to turn it into a headquarters and supply depot after the war. That is where the 1st California was mustered out in 1866.

So, a Sharps carbine, possibly in use by the 1st California, and subsequently turned in at Bairds Ranch, and the personal revolver of Spruce Baird come back together to tell the story of "Bairds Ranch". I wish everyone could watch the video of Bob's talk because he can explain it all so much better than I can. Needless to say, this is real history that a master of gun collecting and history has elucidated through research!

He picked up another gun and went on to describe a copy of the 1859 Sharps Carbine he has and how it differed from the original. Why would he care about a copy? Because it was made in 1863 by C.S Robinson in Richmond VA!

Bob went on to talk about a .44 Allan and Wheelock revolver owned by David Wm Oyler. He served with Quantrill's Raiders during the war. This revolver was purchased from the great granddaughter. The story she told was that her great grandfather kind of disappeared for about a five-year period after the war. Sometime later he had some friends come visit the farm. The friends names were Frank James and Cole Younger. Perhaps that could account for where he was for the missing 5 years!

Bob had some bowie knives with stories as well as a presentation grade, pattern 1850 Staff and Field officer's sword. The scabbard had a presentation plaque that described its presentation to Captain Wm H Stolzenbach from the Loyal Citizens of Bethlehem PA. The irony is that the captain lost his right hand in the battle of Atlanta and so he was now unable to use this presentation sword.

I did not do justice to Bob's talk, but I hope I have given you a glimpse of the history Bob has uncovered. In my humble opinion he is a National treasure and without him this history would be lost. These artifacts and the stories they illustrate bring history to life! Please, if there is any way for you to watch Bob's presentation on video, I would highly recommend it.
